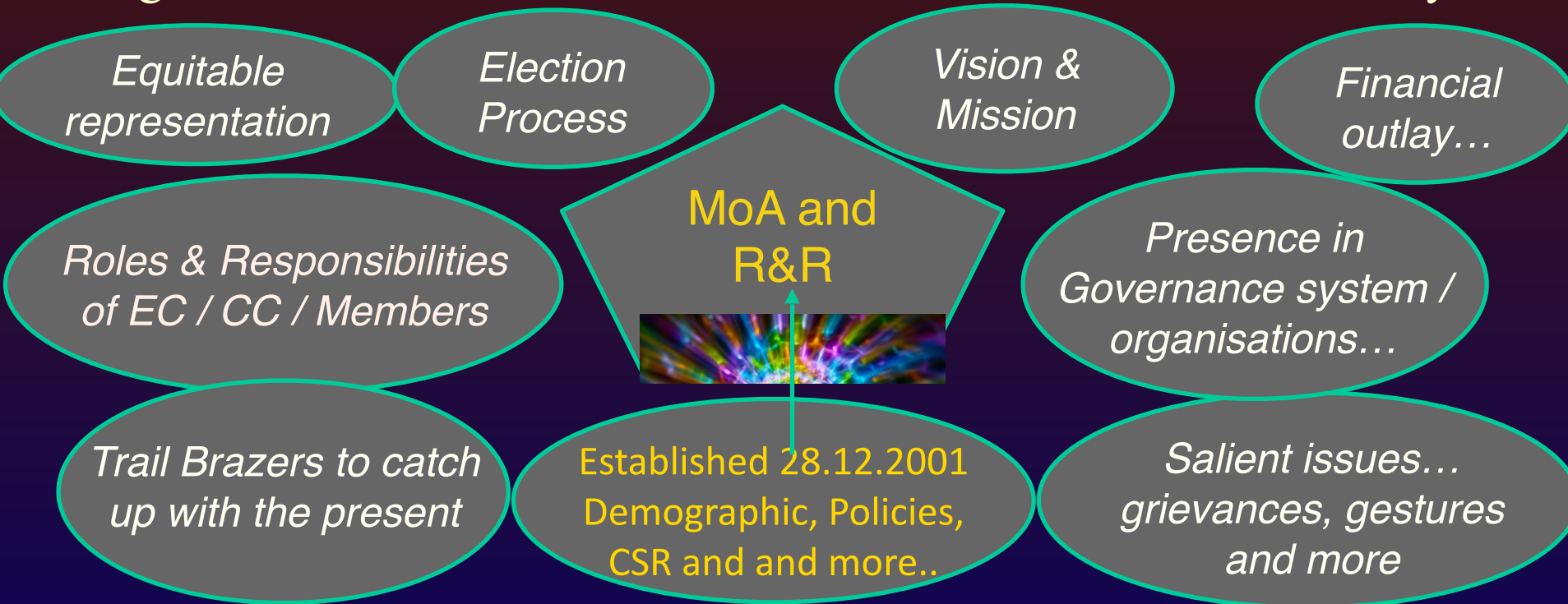

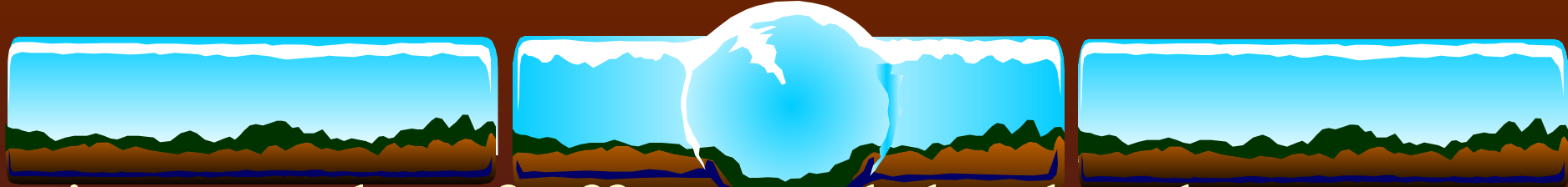
A journey on UN platforms 1999 onwards...

- ❖ The valuable inputs could be obtained from Chattisgarh (Shri CP Deoras, Past VP), West Bengal (Shri SR Chakraborty, Jt. Secretary), Rajasthan (Shri ML Khatod VP), Uttarakhand (Shri MK Raina VP), Telangana (Dr. VBJ Rao Chelikani, Chairman News Council) Goa (Shri Inder Mohan Bhalla Past President), Kerala, Odisha (Shri KS Sahoo & Dr. PK Das), Punjab (Shri SP Karkara past VP), Uttar Pradesh (Shri VK Sharma Past VP), Karnataka (Shri Bendigiri President Karnataka Federation) and Maharashtra States besides contribution by the amendment committee members.
- ❖ The Constitution Amendment committee had its final meeting on January 07, 2025 wherein it was resolved to submit the final recommendations...
- ❖ Accordingly the final recommendations were submitted to The President and Secretary General on January 08, 2025 for next steps of consent by EC, approval by AGM and concurrence of the Charity Commissioner.

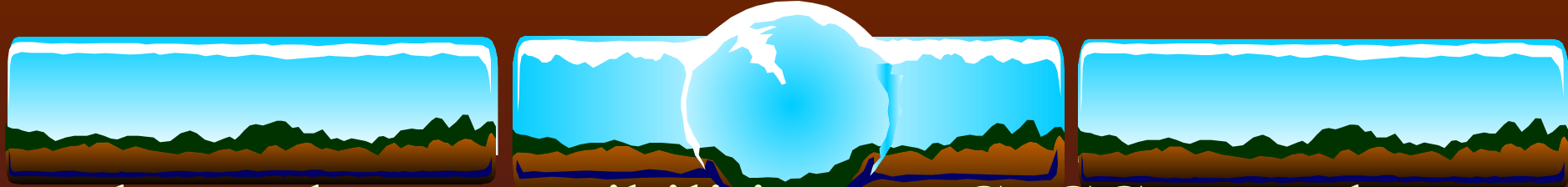

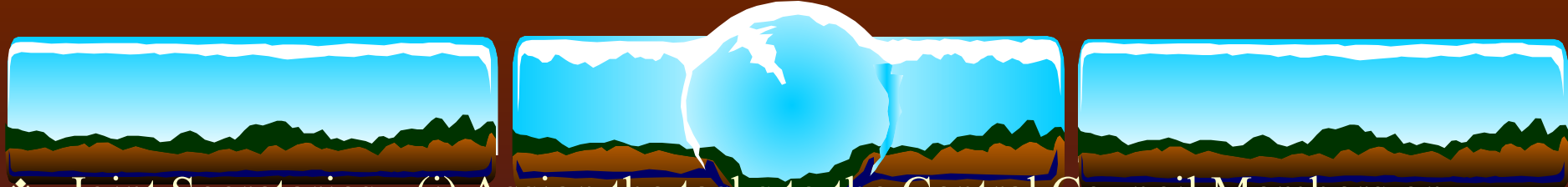

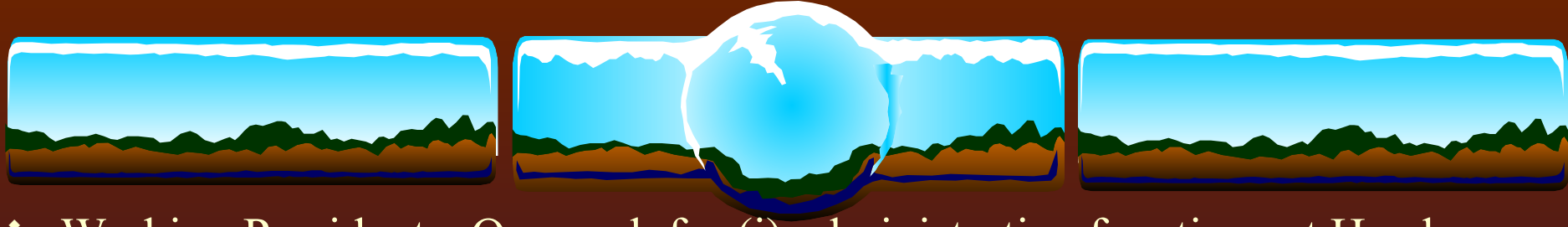


Roles and Responsibilities...EC, CC, Members...

- ❖ Central Council Members : (I) 6 or more visits per year to SCAs of districts / towns / Talukas / Villages - apprise them of senior citizens rights, avenues of existing facilities covered by the Government schemes, helpline, police, welfare, tribunal and more... (ii) encourage the talents to come forward and inform them of the possibilities like livelihood projects, active ageing and more (iii) seek articles and contribute in the local functions / meetings / conferences by extending the services (iv) work for disseminating information about AISCCON's vision / mission, Newsletter contents and related developments (v) For intergenerational equity nurture social fabric for collective good and enhance the stature of AISCCON at grassroots level. (vi) training in digital literacy and the inherent risk.



- ❖ Joint Secretaries - (i) Assign the tasks to the Central Council Members on monthly program basis (ii) Get involved in the activities of Central Council Members with 3 or more visits per year to SCAs of districts / towns / talukas / villages (iii) Promote membership drive, seek funding for AISCCON's activities that includes for sustaining the elderly visits expenditures ; wherever solicited. (iv) Implement the directives as they come from the regional Vice Presidents / Secretaries.
- ❖ Secretaries - (I) Translate the plan as given by the Vice President in action plan to be implemented by Jt. Secretaries / Central Council Members (ii) Prepare the budget proposals / funding prospects reports and submit to the Vice President. (iii) Approve the expenditure bills of the Jt. Secretaries / Central Council members for payment by AISCCON. (iv) Prepare a monthly report of activities undertaken and send it to the Vice President
- ❖ Vice President - (I) Overall surveillance supervision of all the activities in their respective region (ii) Track of expenditures / funding support (iii) Encourage for more local activities (iv) Organise at least 2 meetings every year with AISCCON's HQ presence in the State. (V) Organise at least 1 meeting every year for intermingling with other States.



- ❖ Working Presidents: One each for (i) administrative functions at Head Office, (ii) liaison with Government in Delhi and (iii) public relations / coordination with all the affiliates.
- ❖ Trail Brazers - (I) Overall surveillance of national wide activities of AISCCON (ii) Provide inputs / guidance for qualitative and quantitative improvements (iii) Hold at least one meeting per year with President / Vice President / Secretary General (iv) Get involved in efforts for raising AISCCON's stature at National / International level (v) Act as a think tank for collective good of senior citizens. The trail brazers to be inducted after ascertaining their consent for continuing serving on honorary services. However the direct expenses for mobility / travels etc., to be reimbursed.
- ❖ President / Secretary General - All the administrative functions and ensuring cordial relations. President / Secretary General will be guided and directed by the Executive Committee.
- ❖ Finance Secretary - All the matters for sound financial management, audit, annual report and additional fund collection strategy, etc.,



- ❖ The past dignitaries can join as honorary advisory think tank
- ❖ Presence in Governance system / recognitions in national and State levels.
- ❖ Hold AGM in HQ and other conferences / meetings in various States
- ❖ Promote rights of senior citizens - United Nations and Government of India.
- ❖ Formation of trail-blazers committee for steering the EC
- ❖ Aim at improving the inclusiveness and intermingling amongst affiliates
- ❖ Raise the stature of AISCCON at National and International level.
- ❖ convey samvedanayein for the office bearers on attaining life transition.
- ❖ FESCOM did seed support to AISCCON, now the tree has grown.
- ❖ Each outgoing Executive Committee Member to summarise achievements
- ❖ Women should be represented in each state, and a separate women's wing
- ❖ The EC members should visit Federations at least twice in a year
- ❖ Take up innovative steps for seeking grants / raising funds etc.,.
- ❖ Explore, Identify, Harness in-house talents for various activities

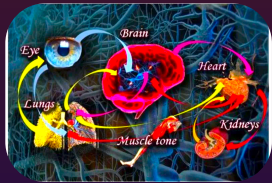
